I acknowledge that conditions may be hazardous and dangerous and that obstructions may exist and I hereby voluntarily assume all risk of loss, damage, or injury, including death that may be sustained by me or to any of my property while in or upon said premises or engaged in the Event as a volunteer.

I further agree and give permission to use photographic images, still or otherwise, of me in promotions for the Event without compensation.
